


### **Last Meeting News**

- Pre-financing was distributed to all the partners with the model we discussed last time
  - 60% of pre-financing distributed to all partners
  - 40% will be provided once the reports of the 12 months activities are provided to the coordinator
  - All partners with pre-financing < 20k€ received 100% already now</li>
  - An effort was made to provide EGO more (80k€)
- We plan to consult in 6 months time to the partners the status in the execution of the funds
- We distributed the Collaborative Agreement v0.0 to the national representatives & administrators → collecting comments until 6<sup>th</sup> October before producing the v1.0

## **Collaborative Agreement**

- We received comments to V0 that are now being implemented in v1
- Some institutions did not answer (DESY, CARDIFF). Please send us feedback soon.
- → Minor comments on definitions and wording all implemented by now
- → Some specific text added for Associated Partners
- → Alternative text suggested for
  - → 7.1.2 Justifying Costs (limited to EC costs)
  - → 7.1.4 Excess payments (breaching Beneficiary)
  - → 8.2 Joint ownership
  - $\rightarrow$  8.4.2.4 (Dissemination)
  - → 10.1 (Non-disclosure of information)
  - → 11.8 (Settlement of disputes)



A dynamic V0.5 will be distributed to you this week for your consultation

We will include the suggested pieces of text when alternatives are coming from different institutions for clarity

In parallel we will produce v1

#### **Notes on Third Parties**

- Today we will offer details on the role and status of third parties.
- Our (new) EC PO suggested to recover the Table 3j in GA to be in the position to monitor properly the third-parties in-kind contributions
  - This requires a letter of commitment between Third-Parties and Beneficiaries
  - A template is ready and will be provided to the Beneficiaries
- An amendment to the GA will be prepared to recover the original Table in the document
  - At the moment only including existing third parties
  - This opens the possibility to revisit the person-months and declared costs
    (I am expecting very small or no changes at this point)
- Additions of new third parties (if any) will be handled with care
  - ET-PP architecture has limited partners and enlargement needs consensus
  - I will like to see the the CA signed before enlargements are even considered
